
Lower Grafton Council for Young Children and Families launched a new <u>website</u> and an engaging <u>family guide</u> for families looking for resources in the area.

# **Step Up Parents**

Step Up Parents offers financial assistance to New Hampshire grandparents and other relative caregivers who have stepped up to raise the children of parents struggling with substance use disorder. We fill gaps in household budgets and respond to a family's immediate financial needs. By assisting care-givers who are raising children deeply impacted by parental addiction, we give them more than monetary support— we give them hope and remind them that they are not alone. Step Up Parents destigmatizes substance misuse and provides a safe forum in which caregivers can ask for help. Step Up Parents believes that "even heroes need a hand."

You may apply directly or if you are working with a social worker or case worker, they may apply on your behalf. Typically, we respond to an application within 24 hours and make a funding decision and distribution within 48 hours. We do not give money directly to families but rather pay vendors and service providers directly on their behalf or supply a gift card for requested items. 
