# Statewide Recruitment and Retention

Public Consulting Group (PCG) has been contracted by the New Hampshire Department of Health and Human Services to focus on early childhood and out of school time recruitment and retention. There are several exciting activities launching in 2024, including implementation of a Survey for the field, asking about experiences related to recruitment and retention, as well as a series of Focus Groups around the state. Generous incentives have been included for those participating! If interested in participating in a Focus Group to share more about your experiences getting into and working in the field, as well as experiences working to recruit staff, please complete this Focus Group Interest Form.

These activities will comprise components of a statewide Recruitment and Retention study. The study will also include findings from a series of piloted innovative approaches which will be occurring around the state between now and September 2024. Additionally, PCG will also be releasing several resources for the field including a Workforce Recruiting Kit, Workforce Recruiting Guide, and several new professional development offerings. # Children with Disabilities Procedural Safeguards and Surrogate Parents

When children are referred for Birth to 3 services (Family Centered Supports and Services) or to a school district for a special education evaluation after age 3, there are many specific timelines and rules that area agencies and school districts must follow. The procedural safeguard handbook must be given or offered to the parents at least once a year and at specific other times during the process. Both handbooks were updated in 2023.
